Minister of Finance - Remarks for the DFA Signing with DFAT

Your Excellency Ms Emily Luck, High Commissioner of Australia to Samoa.

Firstly, allow me your Excellency to give thanks to our Heavenly Father for his never ending love and protection on Samoa during these challenging times as COVID-19 cases continue to escalate and spread in the community. Our Lord our Saviour is our refuge and strength, and is always ready to help our people in times of trouble.

I am pleased to represent the Government of Samoa on this virtual grant agreement signing ceremony for the "Samoa Fiscal Resilience Program and the COVID19 Support Package Assistance". I acknowledge the support of our entire country and communities. We also acknowledge with thanks the full commitment of all the people involved in the management and operations of our COVID 19 preparation and response, in particular our front liners who have been working tirelessly since the health pandemic surfaced globally for the safety and health of Samoa.

Excellency, the Government looks forward to the ongoing engagement and partnership with Australia as one of its key development partner and friend to
